10 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is advertising for bids from certified
11 contractors for the above project.

12 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**
13 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes
14 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

26 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time
27 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

28 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference number:

30 bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be opened after 2:00 P.M. CDT.

34 In general, the work consists of: Replacing an existing concrete pedestrian ramp and stairs at the main building
35 entrance and replacing existing metal handrails at the loading dock stairs. Work includes demolition, new concrete
36 structure, new metal railings, and asphalt pavement restoration.

38 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable
39 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding
40 documents may also be available at various Builders' Exchanges. Additional project bidding information, including

48 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD Information
49 System.

51 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**
52 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**

1 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**
2 **affect the Federal Davis Bacon Act requirements.**

4 No in-person pre-bid tour will be offered. Bidders are welcome to visit the site to walk the exterior to see conditions
5 during the hours of 8:00 am – 5:00 pm. A parking permit is required. Please obtain a permit at the Visitor Center
6 located at 826 W. Starin Road.
