DFD will publicly bid the applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work first. Within 5 26 27 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each 28 applicable MEP division of work. These successful MEP bids must be included in all general prime 29 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will publicly open general prime contractor bids. General prime contractor bids that do not include the 30 31 successful MEP bids will be rejected.
