12 contractors for the above project.

13 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**
14 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes
15 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

30 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

37 In general, the work consists of: Replace all old undersized, compromised / leaking original 160 deg F hot water
38 supply and return piping for the laundry operations at WSPF. The supply/return lines that are currently routed above
39 the ceiling of the Main Kitchen and Laundry areas then proceeds up to the maintenance mezzanine to the hot water
40 tank storage all needs to be replaced. This work will also include the relocation of the existing circulating pump.

42 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable
43 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding

1 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin’s prevailing wage laws.**
2 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**
3 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**
4 **affect the Federal Davis Bacon Act requirements.**
