16 OWNER: State of Wisconsin, Department of Administration (DOA), Division of Facilities Development,
17 hereinafter termed DFD.

19 **All potential bidders must be certified by DOA prior to submitting bids on state construction**
20 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor
21 certification applications and instructions for completing the form may be obtained from the DOA Website

25 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the
26 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5
27 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each
28 applicable MEP division of work. These successful MEP bids must be included in all general prime
29 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will
30 publicly open general prime contractor bids. **General prime contractor bids that do not include the**
31 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,
32 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts
33 with the successful MEP bidders.

35 Sealed bids will be received as follows, before the time indicated above:

45 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the
46 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.
47 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference
48 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results
49 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

53 In general, the work consists of abatement and demolition of the existing Hagestad building, work at the
54 existing chiller plant, a new 3-story Science and Technology Innovation Center and associated site work,

1 housing teaching labs, research labs, offices, non-classroom learning spaces, and a University-Business
2 Collaboration Center (UBC) of approximately 132,400 square feet (square footage includes Mechanical
3 Penthouse).

27 the division of work they are bidding on when requesting Bidding Documents online. No deposit is
28 required to obtain documents for bidding purposes.

30 **Base Bids will be received as a single lump sum bid for: 2) Fire Protection (Fire Suppression); 3)**
31 **Plumbing; 4) Mechanical (Heating, Ventilating, Air Conditioning); and 5) Electrical.**

33 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

35 **NOTICE: The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin’s**
36 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements on state**
37 **building projects no longer apply. These changes take effect for projects advertised for bid after**
38 **September 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

40 A non-mandatory pre-bid tour is scheduled for February 28, 2023 at 1:00 pm at UW-River Falls, Hagestad
41 Hall, Room 160, 262 East Cascade Avenue, River Falls, WI 54022. ‘Pay by credit card’ parking is available
