14 contractors for the above project.

16 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**
17 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes
18 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

32 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time
33 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

34 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference number:

36 bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be opened after 2:00 P.M. CDT.

40 In general, the work consists of: Replacement of the existing failed epoxy coating in the bathroom wall surface and
41 floor surface.

43 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable
44 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding
45 documents may also be available at various Builders' Exchanges. Additional project bidding information, including

52 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD Information
53 System.

55 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**
56 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**

1 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**
2 **affect the Federal Davis Bacon Act requirements.**

3
4 A non-mandatory pre-bid tour is scheduled for February 13, 2024 at 1:00 p.m. at Flambeau Correctional Center. It is
5 encouraged that contractors attend. Pre-registration is required for all wishing to attend. Each attendee must
6 complete the DOC-2430 Facility Security form (included in this project manual) and email it to Carmen Dohms
7 (Flambeau Correctional Center Superintendent) at carmen.dohms@wisconsin.gov at least 24 hours before the tour.
