16 advertising for bids from certified contractors for the above project.

18 **NOTICE: All potential bidders must become certified by DOA prior to submitting bids on**
19 **state construction projects with budgets over \$50,000.** All bids received from contractors
20 who are not certified will be rejected. **These changes take effect January 1, 2014.** Contractor
21 certification applications and instructions for completing the form may be obtained from the DOA

26 Bids must be received at State of Wisconsin Administration Building, 101 East Wilson Street, 7th
27 Floor Reception Desk, Madison, Wisconsin 53703, on or before the closing date and time
28 indicated above.

30 In general the work consists of: **Remodeling of an existing flush toilet building containing a**
31 **men's and a women's room. The remodeled area is approximately 300 sf. All plumbing**
32 **fixtures and light fixtures will be replaced with new fixtures. A small water heater will be**
33 **added. The tile floor in both rooms will be removed and replaced with new tile. Wall tile will**
34 **be installed over existing glazed CMU walls and wood ceilings will be sanded and re-**
35 **finished. An exterior concrete slab will be replaced.**

39 Construction bidding documents (drawings, specifications and addenda) may be obtained only
40 as downloadable electronic files (in PDF format) from the Division of Facilities Development
41 website. Construction bidding documents may also be available at various Builders' Exchanges.
42 Additional project construction bidding information, including plan holders list, is available on the
43 DFD website. Please note that a WisBuild login and password are required to download bidding
44 documents. Interested parties may request a WisBuild login and password at the DFD website –
45 allow 2 days to process login and password requests.

47 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**
48 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements**
49 **on state building projects no longer apply. These changes take effect for projects**

1 **advertised for bid after September 23, 2017. This change does not affect the Federal**
2 **Davis Bacon Act requirements.**
