14 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is
15 advertising for bids from certified contractors for the above project.
16

17 **NOTICE: All potential bidders must become certified by DOA prior to submitting bids on**
18 **state construction projects with budgets over \$50,000.** All bids received from contractors
19 who are not certified will be rejected. **These changes take effect January 1, 2014.** Contractor
20 certification applications and instructions for completing the form may be obtained from the DOA

25 Bids must be received at State of Wisconsin Administration Building, 101 East Wilson Street, 7th
26 Floor Reception Desk, Madison, Wisconsin 53703, on or before the closing date and time
27 indicated above.

29 In general the work consists of: **pulverizing and repaving a portion of the perimeter road**
30 **around the correctional facility. Minor storm sewer work and existing manhole**
31 **reconstruction will also be involved. All work will be outside of the prison security fences.**

34 Construction bidding documents (drawings, specifications and addenda) may be obtained only
35 as downloadable electronic files (in PDF format) from the Division of Facilities Development
36 website. Construction bidding documents may also be available at various Builders' Exchanges.
37 Additional project construction bidding information, including plan holders list, is available on the
38 DFD website. Please note that a WisBuild login and password are required to download bidding
39 documents. Interested parties may request a WisBuild login and password at the DFD website –
40 allow 2 days to process login and password requests.

42 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**
43 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements**
44 **on state building projects no longer apply. These changes take effect for projects**
45 **advertised for bid after September 23, 2017. This change does not affect the Federal**
46 **Davis Bacon Act requirements.**

4 3PM, with the names of any individual planning to attend the tour. Attendees will need to fill out
5 and provide security forms which are included in the Agency Specific Requirement, GRSP section
6 of this project manual and will need to be returned at least 24 hours in advance of the prebid tour.
7 Failure to visit the site or failure to examine any and all Contract Documents will in no way relieve
8 the successful contractor from necessity of furnishing any materials or equipment or performing
9 any work in accordance with the Contract Documents.
