15 OWNER: State of Wisconsin, Department of Administration, Division of Facilities Development,
16 hereinafter termed DFD.

18 **NOTICE: Effective January 1, 2014, all potential bidders must be certified by DOA prior to submitting**
19 **bids on state construction projects over \$50,000.** All bids received from contractors who are not certified
20 will be rejected. Contractor certification applications and instructions for completing the form may be
21 obtained from the DOA Website DFD Contractor Certification page:

25 **This project is being let using a new single prime bidding and contracting process.** DFD will publicly
26 bid the applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within
27 5 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each
28 applicable MEP division of work. These successful MEP bids must be included in all general prime contractor
29 bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will publicly open
30 general prime contractor bids. **General prime contractor bids that do not include the successful MEP**
31 **bids will be rejected.** The state will enter into a single contract with the lowest, qualified, responsible,
32 certified general prime contractor and this general prime contractor will enter into subcontracts with the
33 successful MEP bidders.

35 Sealed bids will be received at the State of Wisconsin Administration Building, 7th Floor, 101 East Wilson
36 Street, Madison, Wisconsin 53703, before the time indicated above. The bidder is responsible for the sealed
37 bid being delivered to the indicated location for receipt stamping before the time specified for the bid opening.
38 Third party delivery is entirely at the bidder's risk.

40 In general the work consists of renovation of Building 41, approximately 27,000 sf, to update building
41 environmental systems and building space layout. Work includes, but is not limited to demolition of interior
42 and exterior elements, masonry and metal stud/gypsum board walls, replacement of drill floor HVAC units
43 and system, wire cage storage and shelving, upgrades to weapons vault and related lighting and power
44 upgrades.

9 Bidder shall identify the division of work they are bidding on when requesting Bidding Documents online.

11 **Base Bid will be received for: A single lump sum bid for All Work.**

12
13 No deposit is required to obtain documents for bidding purposes.

15 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

17 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD
18 Information System.

20 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing
21 wage laws. Effective September 23, 2017, state prevailing wage requirements on state building
22 projects no longer apply. These changes take effect for projects advertised for bid after September
23 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

25 **There will be no formal group pre-bid tour for this Re-bid project. Per section 2 of the Instructions
26 to Bidders, Bidders are still responsible for visiting and examining the site to become acquainted
27 with the adjacent areas, means of approach to the site, conditions of actual job site, and facilities for
28 delivering, storing, placing, and handling of materials and equipment. Failure to visit the site or
29 failure to examine any and all Bidding Documents will in no way relieve the successful Bidder from
30 the necessity of furnishing any materials or equipment, or performing any work, that may be
31 required to complete the work in accordance with the Bidding Documents. Neglect of above
32 requirements will not be accepted as reason for delay in the work or additional compensation.**
