14 advertising for bids from certified contractors for the above project.

16 **NOTICE: All potential bidders must become certified by DOA prior to submitting bids on**
17 **state construction projects with budgets over \$50,000.** All bids received from contractors
18 who are not certified will be rejected. These changes take effect January 1, 2014. Contractor

24 Bids must be received at State of Wisconsin Administration Building, 101 East Wilson Street, 7th
25 Floor Reception Desk, Madison, Wisconsin 53703, on or before the closing date and time
26 indicated above.

28 In general the work consists of: **Work includes the replacement of the air handling unit with**
29 **a steam coil for heating and pneumatic controls. There will be a new air handling unit**
30 **with face and bypass steam coil and control valves, supply fan, outside air damper and**
31 **some ductwork to reconnect to the existing duct supply main. The controls currently are**
32 **past their useful life and will be upgraded to a standalone DDC controls with the**
33 **actuation being electric due to the existing air compressor is not operating at 100%**
34 **capacity. The existing lighting in the mechanical room is being upgraded to LED type**
35 **fixtures and the new air handling unit will require power connections to the unit. All work**
36 **will be completed in the South Housing and the contractor can leave a job box in the**
37 **basement mechanical room where it can be locked up when not in use.**

39 Construction bidding documents (drawings, specifications and addenda) may be obtained only
40 as downloadable electronic files (in PDF format) from the Division of Facilities Development
41 website. Construction bidding documents may also be available at various Builders' Exchanges.
42 Additional project construction bidding information, including plan holders list, is available on the
43 DFD website. Please note that a WisBuild login and password are required to download bidding
44 documents. Interested parties may request a WisBuild login and password at the DFD website
45 – allow 2 days to process login and password requests.
