14 OWNER: State of Wisconsin, Department of Administration, Division of Facilities Development,  
15 hereinafter termed DFD.

16  
17 **All potential bidders must be certified by DOA prior to submitting bids on state construction**  
18 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor  
19 certification applications and instructions for completing the form may be obtained from the DOA Website  
20 DFD Contractor Certification page: <https://doa.wi.gov/Pages/DoingBusiness/ContractorCertification.aspx>

23 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the  
24 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5  
25 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each  
26 applicable MEP division of work. These successful MEP bids must be included in all general prime  
27 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will  
28 publicly open general prime contractor bids. **General prime contractor bids that do not include the**  
29 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,  
30 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts  
31 with the successful MEP bidders. If a project does not include any mechanical, electrical, plumbing, or fire  
32 protection divisions of work, DFD will bid one bid package for all work to general prime contractors.

34 Sealed bids will be received as follows, before the time indicated above:

44 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the  
45 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.

46 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference  
47 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results  
48 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

51 In general, the work consists of: renovating the dry cells to wet cells in Units 9 and 10 in the North  
52 Building of Wisconsin Resource Center. Sawcutting the existing slab on grade concrete floor for  
53 installation of new underground plumbing, concrete patching, installation of detention plumbing fixture in  
54 the cells, adding access doors to the chases, new flooring, ceiling tile, light fixtures, mechanical air handler,

1 mechanical diffusers, painting, adding windows, remodeling existing showers, new detention doors,  
2 hardware and glazing.

14 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in  
15 PDF format): as a downloadable file from the Division's Projects Bidding website (see website address  
16 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities  
17 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding  
18 information, including plan holders lists are available on the Division of Facilities Development public  
19 website: <https://doa.wi.gov/Pages/AboutDOA/FacilitiesDevelopment.aspx>. After opening the web page,  
20 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify  
21 the division of work they are bidding on when requesting Bidding Documents online. No deposit is  
22 required to obtain documents for bidding purposes.

24 **Base Bid will be received for: A single lump sum bid for All Work.**

25  
26 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

27  
28 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD  
29 Information System.

30  
31 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing**  
32 **wage laws. Effective September 23, 2017, state prevailing wage requirements on state building**  
33 **projects no longer apply. These changes take effect for projects advertised for bid after September**  
34 **23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

35  
36 A non-mandatory pre-bid tour scheduled for Tuesday, June 27 at 10:00 am. at Wisconsin Resource Center.  
37 Attendance is highly recommended. Participants should meet at the Gatehouse Building at 1505 North  
38 Drive, Oshkosh, WI where they will be escorted throughout the project areas by facility staff. All bidders  
39 are highly encouraged to attend and no separate tours will be conducted. Contractors interested in attending  
40 the Pre-Bid tour shall provide the required information to facilitate background checks for attendees in  
41 advance of the meeting.

43 Any person wanting to attend the Pre-Bid Tour will be required to fill out the included Contractor Entrance  
44 Procedure, Expectations, and Acknowledgement form and send to
