11 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is advertising for bids from certified
12 contractors for the above project.
13

14 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**
15 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes
16 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

21 Sealed bids will be received as follows, before the time indicated above:

30 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time
31 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

32 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference number:
33 (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results announced on the day
34 bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be opened after 2:00 P.M. CDT.

37 In general the work consists of: the demolition and replacement of the Central Wisconsin Center's Food Service
38 Trayline Conveyor. The existing food service trayline conveyor is electrically operated. Measures overall at twenty-
39 eight (28) feet in length. The length of the new conveyor depends on the selected manufacturer. It may be shorter in
40 length. The replacement work entails the engineering, fabrication, electrical wiring, installation, commissioning, and
41 personnel training of the new food service tray conveyor system.
42

43 The existing trayline conveyor shall be operational until the new equipment arrives on-site, is pre-assembled, new
44 wiring is completed, and the replacement equipment is readied to move into installation.
45 A period of ten (10) days is provided for all pre-assembly, verification, and preparatory electrical wiring. The
46 staging area is the adjacent Canteen.
47

48 The new system shall be **installed and operational within a maximum period of 24 consecutive hours, from**
49 **6:00 p.m. on start day to 6:00 p.m. the next calendar day.**
50 **This is an Agency operational requirement.**

52 Included in the installation period: decommission and removal of existing equipment; removal of outdated electrical
53 wiring; final assembly of new equipment; activation of remaining electrical connections; commissioning of
54 equipment; and immediate training of the operational personnel.

56 The 24-hour maximum time-window for Contractor demolition and removal of existing is immediately followed by
57 the complete installation. Complete installation shall include commissioning and personnel training of the new
58 trayline conveyor system.

1 Electrical work specifics include but not limited to: the existing floor conduit poke-thru which extends from the
2 basement ceiling to the kitchen floor level. There is a line box (LB) at the ceiling level downstairs, and a LB at the
3 kitchen floor level upstairs. The conduit stub is a 1-1/2" ridged conduit (threaded). The new design shall dismantle
4 the existing raceway between the panelboard and the abandoned buss plug downstairs. Continuous feed for the new
5 conveyor from the existing panelboard. Intercept the existing raceway, suitably, to minimize cutover tie and
6 reutilize the existing 1-1/2" conduit stub.

8 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable
9 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding
10 documents may also be available at various Builders' Exchanges. Additional project bidding information, including
11 plan holders lists are available on the Division of Facilities Development public website:

13 Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify the division of work
14 they are bidding on when requesting Bidding Documents online. No deposit is required to obtain documents for
15 bidding purposes.

17 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD Information
18 System.

20 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**
21 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**
22 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**
23 **affect the Federal Davis Bacon Act requirements.**

24
25 A formal pre-bid tour will not be conducted for this project; however, a site visit is encouraged.
