17 OWNER: State of Wisconsin, Department of Administration (DOA), Division of Facilities Development,
18 hereinafter termed DFD.

19
20 **All potential bidders must be certified by DOA prior to submitting bids on state construction**
21 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor
22 certification applications and instructions for completing the form may be obtained from the DOA Website

26 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the
27 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5
28 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each
29 applicable MEP division of work. These successful MEP bids must be included in all general prime
30 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will
31 publicly open general prime contractor bids. **General prime contractor bids that do not include the**
32 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,
33 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts
34 with the successful MEP bidders.

36 Sealed bids will be received as follows, before the time indicated above:

46 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the
47 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.

49 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference

51 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

1 In general, the work consists of: a new 3,639 square foot retail building, 1,479 square foot toilet room
2 building, connected by a 4,162 square foot covered plaza, and new site infrastructure. The project is
3 located at W372 S9727 Hwy 67 on the Old World Wisconsin Outdoor Ethnic Museum site located in
4 Eagle, Wisconsin. The work scope includes cast-in-place concrete, unit masonry, limestone, structural steel
5 framing, metal fabrications, metal stairs, pipe and tube railings, rough carpentry, sheathing, shop-fabricated
6 wood trusses, glue-laminated construction, interior and exterior finish carpentry, interior architectural
7 woodwork, sheet waterproofing, insulation, air barriers, standing seam metal roofing, sheet metal flashing
8 and trim, sheet metal roofing specialties, sealants, hollow metal doors and frames, flush wood doors, stile
9 and rail wood doors, access doors and frames, aluminum storefront, hardware, glazing, decorative windows
10 films, fixed louvers, GWB, ceramic tiling, acoustical ceiling tiles, resilient flooring and base, resinous
11 flooring, tile carpeting, painting, high performance coatings, visual display surfaces, signage, building
12 dedication plaque, dimensional letter signage, toilet compartments, wall and door protection, toilet
13 accessories, fire extinguishers and cabinets, roller window shades, metal casework, plumbing, HVAC, site
14 lighting, lighting and light controls, electrical / communications wiring, lightning protection, audio-visual,
15 access control, video surveillance, site clearing, earthmoving, trenching, erosion control, asphalt paving,
16 decorative metal fences, plants, seeding, sodding, water utility distribution, sanitary sewerage utilities,
17 storm drainage utilities, and fuel distribution utilities.

38 **Base Bids will be received as a single lump sum bid for: 3) Plumbing; 4) Mechanical (Heating,**
39 **Ventilating, Air Conditioning); and 5) Electrical.**

41 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

43 **NOTICE: The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**
44 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements on state**
45 **building projects no longer apply. These changes take effect for projects advertised for bid after**
46 **September 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

48 A pre-bid tour will be conducted at the site on the site on December 19, 2023 at 10:00am. Participants should
49 enter the Old World Wisconsin site using Gate 4 (The Main Gate), located at W372 S9727 Hwy 67, Eagle,
