13 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is advertising for bids from certified  
14 contractors for the above project.

15  
16 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**  
17 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes  
18 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

23 Sealed bids will be received as follows, before the time indicated above:

- 29 • **Hand delivery to the drop box labeled SEALED BIDS ONLY in front of the State of Wisconsin**  
30 **Administration Building located at 101 East Wilson Street, Madison, Wisconsin 53703.**

32 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time  
33 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

34 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference number:  
35 (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results announced on the day  
36 bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be opened after 2:00 P.M. CDT.

39 In general the work consists of: removal and replacement of retaining wall, concrete sidewalk, earthwork, dense  
40 graded base, and sod turf re-establishment.

42 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable  
43 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding  
44 documents may also be available at various Builders' Exchanges. Additional project bidding information, including  
45 plan holders lists are available on the Division of Facilities Development public website:

47 Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify the division of work  
48 they are bidding on when requesting Bidding Documents online. No deposit is required to obtain documents for  
49 bidding purposes.

51 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD Information  
52 System.

54 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**  
55 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**  
56 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**  
57 **affect the Federal Davis Bacon Act requirements.**
