11 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is advertising for bids from certified
12 contractors for the above project.

13 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**
14 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes
15 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

20 Sealed bids will be received as follows, before the time indicated above:

29 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time
30 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

31 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference number:
32 (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results announced on the day
33 bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be opened after 2:00 P.M. CDT.

36 In general the work consists of: Removal of existing obsolete control panels, PLCs, audio equipment and
37 replacement with new PCs, HMIs, PLCs and audio equipment associated with door controls, paging and intercoms.
38 Provide a new Ethernet network for door controls.

40 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable
41 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding
42 documents may also be available at various Builders' Exchanges. Additional project bidding information, including
43 plan holders lists are available on the Division of Facilities Development public website:

45 Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify the division of work
46 they are bidding on when requesting Bidding Documents online. No deposit is required to obtain documents for
47 bidding purposes.

49 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD Information
50 System.

52 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**
53 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**

1 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**
2 **affect the Federal Davis Bacon Act requirements.**

3
4 A non-mandatory pre-bid tour is scheduled for January 24, 2023, 10AM at Robert E. Ellsworth Correctional Center.
5 It is encouraged that contractors attend. Contractors interested in attending shall send their full name, date of birth,
6 and state driver's license number, via email to Josh Kratochvil at Joshua.Kratochvil@Wisconsin.gov by January 18,
7 2023, 2PM. Indicate the project number and bid tour time when sending email. Limit two (2) individuals from any
8 separate company for the pre-bid tour. Contractors attending the pre-bid tour shall meet at the Main building lobby.
9 All persons entering the facility shall comply with any COVID protocols that may be in effect.

11 Bidding Documents will be available online immediately upon the project being advertised for bid.
