9 contractors for the above project.

11 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**
12 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes
13 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

35 In general, the work consists of: The demolition work will include removing the existing vertical joint sealants and
36 existing stone coping from the exterior of Jeter, Tainter, and Callahan Halls. The work will also entail removing
37 existing roofing material from identified roof sections. The new work will include installing new sealants in all of
38 the vertical joints throughout the entirety of the three buildings, installing a new metal coping cap at the existing
39 stone cap locations, and installing a new fully adhered EPDM roof on the identified roof sections.

41 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable
42 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding
43 documents may also be available at various Builders' Exchanges. Additional project bidding information, including

1 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**
2 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**
3 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**
4 **affect the Federal Davis Bacon Act requirements.**
