These successful MEP bids must be included in all general prime 28 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will publicly open general prime contractor bids. General prime contractor bids that do not include the 29 30 successful MEP bids will be rejected.
