14 OWNER: State of Wisconsin, Department of Administration (DOA), Division of Facilities Development,
15 hereinafter termed DFD.

17 **All potential bidders must be certified by DOA prior to submitting bids on state construction**
18 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor
19 certification applications and instructions for completing the form may be obtained from the DOA Website

23 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the
24 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5
25 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each
26 applicable MEP division of work. These successful MEP bids must be included in all general prime
27 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will
28 publicly open general prime contractor bids. **General prime contractor bids that do not include the**
29 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,
30 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts
31 with the successful MEP bidders.

33 Sealed bids will be received as follows, before the time indicated above:

43 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the
44 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.
45 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference
46 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results
47 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

51 In general, the work consists of: Construction of a communications tower and shelter for the radio system
52 serving Winnebago Mental Health Institute, Wisconsin Resource Center, Drug Abuse Correctional Center
53 and Winnebago Correctional Center. New underground fiber optic and power cabling will be installed to
54 the new equipment shelter.

20 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

22 **NOTICE: The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**
23 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements on state**
24 **building projects no longer apply. These changes take effect for projects advertised for bid after**
25 **September 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

33 one (1) individual from any separate company for the pre-bid tour. Contractors attending the pre-
34 bid tour shall meet at the main entrance of Administration building. COVID protocols are in effect at the
35 facility which include wearing of masks when inside of buildings.
