17 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes

32 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time
33 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

39 In general the work consists of: replacement of the elevator controls, power units, signal fixtures, and some door
40 operator equipment on two Schindler hydraulic passenger elevators. The project scope includes the related electrical
41 and fire alarm upgrades and all cutting and patching.

43 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable
44 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding
45 documents may also be available at various Builders' Exchanges. Additional project bidding information, including

53 System.

55 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**
