33 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

39 In general, the work consists of: Replacement of one (1) low pressure steam boiler. Including associated electrical
40 and piping work.

54 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**

56 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**
57 **affect the Federal Davis Bacon Act requirements.**
