14 OWNER: State of Wisconsin, Department of Administration (DOA), Division of Facilities Development,  
15 hereinafter termed DFD.

16  
17 **All potential bidders must be certified by DOA prior to submitting bids on state construction**  
18 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor  
19 certification applications and instructions for completing the form may be obtained from the DOA Website

23 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the  
24 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5  
25 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each  
26 applicable MEP division of work. These successful MEP bids must be included in all general prime  
27 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will  
28 publicly open general prime contractor bids. **General prime contractor bids that do not include the**  
29 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,  
30 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts  
31 with the successful MEP bidders.

33 Sealed bids will be received as follows, before the time indicated above:

- 39 • **Hand delivery to the drop box labeled SEALED BIDS ONLY in front of the State of**  
40 **Wisconsin Administration Building located at 101 East Wilson Street, Madison, Wisconsin**

43 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the  
44 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.

45 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference  
46 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results  
47 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

51 In general, the work consists of:

52 Contractor to remove the existing walk-in cooler/freezer units and install new walk-in cooler/freezer units  
53 of the same overall size (approximately one thousand, four hundred square feet), and location (First Floor  
54 which is up one level from grade via stairs or elevator), but with an altered interior configuration. The  
55 existing units involve two freezer sections and five cooler sections. The new configuration will consist of

1 two freezer sections and three cooler sections. Existing condensing units in an adjacent room will be  
2 removed and replaced. Disconnect the existing electrical connections and reconnect new system. Patch  
3 adjacent walls and repaint. Rework ceiling/soffit and grid system around new units. This project will  
4 repair/replace floor surfaces and fillers adjacent to the coolers and freezers, and apply a new coat of epoxy  
5 floor finish adjacent to the new units as well as surrounding kitchen areas.

7 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in  
8 PDF format): as a downloadable file from the Division's Projects Bidding website (see website address  
9 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities  
10 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding  
11 information, including plan holders lists are available on the Division of Facilities Development public  
12 website: <https://doa.wi.gov/Pages/AboutDOA/FacilitiesDevelopment.aspx>. After opening the web page,  
13 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify  
14 the division of work they are bidding on when requesting Bidding Documents online. No deposit is  
15 required to obtain documents for bidding purposes.

17 **Base Bids will be received as a single lump sum bid for: 5) Electrical.**

18  
19 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

20  
21 **NOTICE: The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**  
22 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements on state**  
23 **building projects no longer apply. These changes take effect for projects advertised for bid after**  
24 **September 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

25  
26 A non-mandatory pre-bid tour is scheduled for **Wednesday, June 21, 2023** promptly at **2:00 pm**, UW Eau  
27 Claire, Hilltop Building, Main Entrance (west end). It is encouraged that contractors attend. Please contact
