DFD will publicly bid the applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work first. Within 5 25 26 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each applicable MEP division of work. These successful MEP bids must be included in all general prime 27 28 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will 29 publicly open general prime contractor bids. General prime contractor bids that do not include the 30 successful MEP bids will be rejected. In general, the work consists of: the rehabilitation of two lift stations. Lift Station 1 improvements include replacement of pumps, valves, and piping, upgrades to the controls, and raising the wet well lid elevation and adjacent grading for drainage improvement. Lift Station 2 includes replacement of the valve vault and
