17 OWNER: State of Wisconsin, Department of Administration (DOA), Division of Facilities Development,
18 hereinafter termed DFD.

20 **All potential bidders must be certified by DOA prior to submitting bids on state construction**
21 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor
22 certification applications and instructions for completing the form may be obtained from the DOA Website

26 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the
27 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5
28 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each
29 applicable MEP division of work. These successful MEP bids must be included in all general prime
30 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will
31 publicly open general prime contractor bids. **General prime contractor bids that do not include the**
32 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,
33 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts
34 with the successful MEP bidders.

36 Sealed bids will be received as follows, before the time indicated above:

47 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.

49 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference

51 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

1 In general, the work consists of: 2,108 square foot interior renovation of the historic Wittnebel's Tavern
2 and a new 1,000 square foot Beer Garden with a 613 square foot sun shade structure. The project is located
3 at W372 S9727 Hwy 67 on the Old World Wisconsin Outdoor Ethnic Museum site located in Eagle,
4 Wisconsin. The work scope includes cast-in-place concrete, pipe and tube railings, architectural woodwork
5 restoration, rough carpentry, sheathing, shop-fabricated wood trusses, interior and exterior finish carpentry,
6 interior architectural woodwork, dampproofing, insulation, weather barriers, asphalt shingles, sheet metal
7 flashing and trim, sealants, stile and rail wood doors, fixed louvers, GWB, wood flooring, resilient flooring,
8 FRP wall panels, painting, plumbing, HVAC, site lighting, lighting and light controls, electrical /
9 communications wiring, video surveillance, earthmoving, trenching, erosion control, plants, seeding, water,
10 and fuel distribution utilities.

31 **Base Bids will be received as a single lump sum bid for: 3) Plumbing; 4) Mechanical (Heating,**
32 **Ventilating, Air Conditioning); and 5) Electrical.**

34 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

36 **NOTICE: The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**
37 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements on state**
38 **building projects no longer apply. These changes take effect for projects advertised for bid after**
39 **September 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

41 A non-mandatory pre-bid tour will be conducted at the site on October 25, 2023, at 10:00AM. Participants
42 should enter the Old World Wisconsin site using Gate 4 (The Main Gate), located at W372 S9727 Hwy 67,
43 Eagle, WI 53119. Parking is available in the main parking lot adjacent to the project site and the tour will
44 meet at the site entry structure (located on the west side of the parking lot). All bidders are highly encouraged
