When 85% or 27 more of the construction cost of a project could be completed by a Single Trade Contractor 28 (mechanical, electrical, plumbing, or fire protection), the Department may bid and contract all work 29 of that construction project directly to a Single Trade Contractor. The State will enter into a single contract with the lowest, qualified, responsible, certified single trade MEP contractor. Single trade 30 31 MEP contractors may bid on single trade projects up to their current division of work certification 32 level for that trade. Effective September 23, 2017, state prevailing wage requirements on state building 23 projects no longer apply. These changes take effect for projects advertised for bid after September 24 23, 2017.
