15 advertising for bids from certified contractors for the above project.

17 **NOTICE: All potential bidders must become certified by DOA prior to submitting bids on**  
18 **state construction projects with budgets over \$50,000.** All bids received from contractors  
19 who are not certified will be rejected. **These changes take effect January 1, 2014.** Contractor  
20 certification applications and instructions for completing the form may be obtained from the DOA

29 In general the work consists of: **replacement of finishes and HVAC and electrical work in a**  
30 **former indoor firing range. Existing rooms affected include a vehicle maintenance bay,**  
31 **storage room, open office and a locker room.**

35 Construction bidding documents (drawings, specifications and addenda) may be obtained only  
36 as downloadable electronic files (in PDF format) from the Division of Facilities Development  
37 website. Construction bidding documents may also be available at various Builders' Exchanges.  
38 Additional project construction bidding information, including plan holders list, is available on the  
39 DFD website. Please note that a WisBuild login and password are required to download bidding  
40 documents. Interested parties may request a WisBuild login and password at the DFD website –  
41 allow 2 days to process login and password requests.

43 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**  
44 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements**  
45 **on state building projects no longer apply. These changes take effect for projects**  
46 **advertised for bid after September 23, 2017. This change does not affect the Federal**  
47 **Davis Bacon Act requirements.**
