15 OWNER: State of Wisconsin, Department of Administration (DOA), Division of Facilities Development,  
16 hereinafter termed DFD.

18 **All potential bidders must be certified by DOA prior to submitting bids on state construction**  
19 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor  
20 certification applications and instructions for completing the form may be obtained from the DOA Website

24 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the  
25 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5  
26 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each  
27 applicable MEP division of work. These successful MEP bids must be included in all general prime  
28 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will  
29 publicly open general prime contractor bids. **General prime contractor bids that do not include the**  
30 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,  
31 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts  
32 with the successful MEP bidders.

34 Sealed bids will be received as follows, before the time indicated above:

44 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the  
45 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.  
46 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference  
47 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results  
48 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

52 In general, the work consists of installing a new 1300-ton centrifugal chiller, associated cooling tower and  
53 pumps within West Chiller Plant. Work also includes installation of approximately 900 lineal feet each of

1 underground chilled water supply and return piping as well as the associated site work needed to  
2 accommodate the new chilled water piping. Entire project area will be restored to original conditions.

6 **Notice is hereby given in accordance with Section 16.855(10), Wisconsin Statutes, that the Division**  
7 **believes it is in the best interests of the State to contract the following work from only one source,**

16 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in  
17 PDF format): as a downloadable file from the Division's Projects Bidding website (see website address  
18 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities  
19 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding  
20 information, including plan holders lists are available on the Division of Facilities Development public  
21 website: <https://doa.wi.gov/Pages/AboutDOA/FacilitiesDevelopment.aspx>. After opening the web page,  
22 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify  
23 the division of work they are bidding on when requesting Bidding Documents online. No deposit is  
24 required to obtain documents for bidding purposes.

26 **Base Bids will be received as a single lump sum bid for: 3) Plumbing; 4) Mechanical (Heating,**  
27 **Ventilating, Air Conditioning); and 5) Electrical.**

28  
29 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

30  
31 **NOTICE: The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**  
32 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements on state**  
33 **building projects no longer apply. These changes take effect for projects advertised for bid after**  
34 **September 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

35  
36 A pre-bid walk thru is scheduled for February 1, 2023, at 10:00 am meet at West Chiller Plant. All  
37 parties interested in attending area required to contact Troy Cunat ([troy.cunat@wisconsin.gov](mailto:troy.cunat@wisconsin.gov)) to  
38 provide appropriate information to gain access before allowed to enter facilities. Contractors shall  
39 contact Troy Cunat no later that (3) days prior to pre-bid walk thru date.
