17 OWNER: State of Wisconsin, Department of Administration (DOA), Division of Facilities Development,  
18 hereinafter termed DFD.

19  
20 **All potential bidders must be certified by DOA prior to submitting bids on state construction**  
21 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor  
22 certification applications and instructions for completing the form may be obtained from the DOA Website

26 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the  
27 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5  
28 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each  
29 applicable MEP division of work. These successful MEP bids must be included in all general prime  
30 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will  
31 publicly open general prime contractor bids. **General prime contractor bids that do not include the**  
32 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,  
33 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts  
34 with the successful MEP bidders.

36 Sealed bids will be received as follows, before the time indicated above:

46 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the  
47 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.  
48 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference  
49 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results  
50 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

1 In general, the work consists of: The replacement of the two (2) existing toilet/shower buildings (buildings  
2 #1923 and #1924) with one (1) new centrally located toilet/shower building serving the campground. The  
3 building will be constructed primarily with cast in place concrete footings and foundations, concrete floor,  
4 concrete masonry unit exterior and interior walls, wood roof trusses, and granular coated steel roof shingles.  
5 The roof is designed to provide shelter at the approach on three sides of the building with an extended roof  
6 and columns providing a sheltered waiting area outside the shower rooms.

7  
8 The existing vault toilets (buildings #1925, #1926, #1927, and #1928) will be demolished. Two (2) new  
9 vault toilets will be constructed at the current location of the existing toilet/shower buildings and also at two  
10 (2) new locations. The vault toilets will be premanufactured precast concrete walls and roof and direct  
11 purchased by the DNR.

12  
13 A parking area for the new toilet/shower building will be constructed and the existing parking areas  
14 upgraded.

15  
16 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in  
17 PDF format): as a downloadable file from the Division's Projects Bidding website (see website address  
18 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities  
19 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding  
20 information, including plan holders lists are available on the Division of Facilities Development public  
21 website: <https://doa.wi.gov/Pages/AboutDOA/FacilitiesDevelopment.aspx>. After opening the web page,  
22 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify  
23 the division of work they are bidding on when requesting Bidding Documents online. No deposit is  
24 required to obtain documents for bidding purposes.

25  
26 **Base Bids will be received as a single lump sum bid for: 3) Plumbing; 4) Mechanical (Heating,**  
27 **Ventilating, Air Conditioning); and 5) Electrical.**

28  
29 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

30  
31 **NOTICE: The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**  
32 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements on state**  
33 **building projects no longer apply. These changes take effect for projects advertised for bid after**  
34 **September 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

35  
36 A non-mandatory pre-bid tour is scheduled for 09:00 A.M., February 6, 2024 at Lake Wissota State Park,  
37 18127 County Highway O, Chippewa Falls, WI. It is encouraged that contractors attend. Assemble at the
