13 OWNER: State of Wisconsin, Department of Administration, Division of Facilities Development,  
14 hereinafter termed DFD.

15  
16 **All potential bidders must be certified by DOA prior to submitting bids on state construction**  
17 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor  
18 certification applications and instructions for completing the form may be obtained from the DOA Website

22 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the  
23 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5  
24 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each  
25 applicable MEP division of work. These successful MEP bids must be included in all general prime  
26 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will  
27 publicly open general prime contractor bids. **General prime contractor bids that do not include the**  
28 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,  
29 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts  
30 with the successful MEP bidders. **If a project does not include any mechanical, electrical, plumbing, or**  
31 **fire protection divisions of work, DFD will bid one bid package for all work to general prime**  
32 **contractors.**

34 Sealed bids will be received as follows, before the time indicated above:

44 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the  
45 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.

46 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference  
47 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results  
48 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

52 In general, the work consists of removing 83,540 square feet of existing synthetic turf soccer field playing  
53 surface along with infill and e-layer shock pad below down to the existing subgrade stone layer. Campus  
54 will contract for the new soccer field playing surface with crumb rubber and infill, the e-layer shock pad,  
55 and the installation of same with a vendor of their choosing. The GPC will be responsible for coordinating

1 with turf contractor selected and contracted by UW Milwaukee. Additional stone, by GPC, shall be added  
2 to level out the surface prior to Campus' turf contractor installing a new 2" height synthetic turf system  
3 crumb rubber and sand infill, and a new shock pad below the entire surface. In addition, GPC concrete and  
4 fencing work is included to correct cracks and settling to adjacent areas of the field.

6 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in  
7 PDF format); as a downloadable file from the Division's Projects Bidding website (see website address  
8 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities  
9 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding  
10 information, including plan holders lists are available on the Division of Facilities Development public  
11 website: <https://doa.wi.gov/Pages/AboutDOA/FacilitiesDevelopment.aspx>. After opening the web page,  
12 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify  
13 the division of work they are bidding on when requesting Bidding Documents online. No deposit is  
14 required to obtain documents for bidding purposes.

16 **Base Bid will be received for: A single lump sum bid for All Work.**

17  
18 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

19  
20 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD  
21 Information System.

22  
23 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing**  
24 **wage laws. Effective September 23, 2017, state prevailing wage requirements on state building**  
25 **projects no longer apply. These changes take effect for projects advertised for bid after September**  
26 **23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

27  
28 A single non-mandatory Pre-Bid conference will be held on Wednesday, January 3<sup>rd</sup> 2024 at 10:30 am at UW  
29 Milwaukee School of Architecture and Urban Planning room AUP 170. The School of Architecture and  
30 Urban Planning is located at 2131 E. Hartford Ave. Milwaukee WI 53211. The conference and walk-through  
31 is scheduled for the purpose of acquainting prospective bidders with the site conditions and special  
32 requirements of the project. All bidders are encouraged to attend this Pre-Bid Conference and no separate  
33 tours will be conducted. Walkthroughs of the field will take place after the pre-bid conference.  
34 Representatives from the A/E's office will be available to take questions for answer in addendum. Prospective  
35 bidders are asked to familiarize themselves with the project documents and requirements prior to the
