When 85% or more 27 of the construction cost of a project could be completed by a Single Trade Contractor (mechanical, 28 electrical, plumbing, or fire protection), the Department may bid and contract all work of that 29 construction project directly to a Single Trade Contractor. The State will enter into a single contract with the lowest, qualified, responsible, certified single trade MEP contractor. Single trade MEP 30 31 contractors may bid on single trade projects up to their current division of work certification level for 32 that trade. All Work for this project will be awarded to a single trade Electrical contractor. Bidders 33 shall submit a Single Base Bid for all Work. 34 35 Sealed bids will be received at the State of Wisconsin Administration Building, 7th Floor, 101 East Wilson 36 Street, Madison, Wisconsin 53703, before the time indicated above. 8 9 The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing 10 wage laws. Effective September 23, 2017, state prevailing wage requirements on state building 11 projects no longer apply. These changes take effect for projects advertised for bid after September

12 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.
