19 hereinafter termed DFD.

21 **All potential bidders must be certified by DOA prior to submitting bids on state construction**
22 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor
23 certification applications and instructions for completing the form may be obtained from the DOA Website
24 DFD Contractor Certification page: <https://doa.wi.gov/Pages/DoingBusiness/ContractorCertification.aspx>
25 or upon request from DFD--email dfdcertification@wisconsin.gov.

27 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the
28 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5
29 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each
30 applicable MEP division of work. These successful MEP bids must be included in all general prime
31 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will
32 publicly open general prime contractor bids. **General prime contractor bids that do not include the**
33 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,
34 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts
35 with the successful MEP bidders.

37 Sealed bids will be received as follows, before the time indicated above:

47 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the
48 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.
49 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference
50 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results
51 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

1 In general the work consists of reconstructing the existing 200 foot long service tunnel that exits the Food
2 Service Building. Damaged concrete sections will be removed and replaced. This includes the entire roof
3 which is above ground as well as damaged wall sections. The top and sides of the reconstructed tunnel will
4 be waterproofed and insulated. Heating and lighting systems inside the tunnel will be replaced. Exterior
5 lights and guardrail at the top of the tunnel will be replaced. Disturbed landscaping will be restored. All
6 work will need to be phased to allow use of the tunnel by staff during peak hours of operation.

10 **Notice is hereby given in accordance with Section 16.855(10), Wisconsin Statutes, that the Division**
11 **believes it is in the best interests of the State to contract the following work from only one source,**
12 **without the usual statutory procedures:**

16 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in
17 PDF format): as a downloadable file from the Division’s Projects Bidding website (see website address
18 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities
19 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding
20 information, including plan holders lists are available on the Division of Facilities Development public

22 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify
23 the division of work they are bidding on when requesting Bidding Documents online. No deposit is
24 required to obtain documents for bidding purposes.

26 **Base Bid will be received for: A single lump sum bid for All Work.**
27

28 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.
29

30 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD
31 Information System.
32

33 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin’s prevailing**
34 **wage laws. Effective September 23, 2017, state prevailing wage requirements on state building**
35 **projects no longer apply. These changes take effect for projects advertised for bid after September**
36 **23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**
37

38 A non-mandatory pre-bid conference will be held on February 2, 2023, promptly at 9:00am. Any party
39 interested in attending will be required to contact Robert Otremba at robert.otremba@wisconsin.gov.
40 Contractors are required to contact Robert Otremba no later than three(3) days prior to the pre-bid date. Items
41 of note about the pre-bid walk through:

- 42 1. Contractors are to meet at the WMHI Administration Building lobby at 9:00am on February
43 2, 2023. Contractors will be screened in the lobby and provided a surgical mask that they may
44 have to wear.
- 45 2. The group will be escorted to the auditorium in the Administration Building to discuss the
46 project.
- 47 3. Contractors will be escorted to the food service tunnel.
- 48 4. Contractors can walk outside where the current tunnel is.
- 49 5. Only one (1) representative per contractor will be allowed for the pre-bid.
50

51 Bidding Documents will be available online immediately upon the project being advertised for bid.
