11 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is advertising for bids from certified  
12 contractors for the above project.

15 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**  
16 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes  
17 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

31 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time  
32 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

33 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference number:  
34 (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results announced on the day  
35 bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be opened after 2:00 P.M. CDT.

39 In general, the work consists of: Replace the existing boiler feedwater treatment equipment. Specific new equipment  
40 to include water softeners, reverse osmosis system, and carbon filters. All associated pumps, piping and valves will  
41 be replaced. Winter heating loads have been reviewed to properly size the new RO system. The existing central  
42 water softeners and dealkalizers to pretreat the boiler make up water at UW Green Bay shall be removed.  
43

44 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable  
45 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding  
46 documents may also be available at various Builders' Exchanges. Additional project bidding information, including  
47 plan holders lists are available on the Division of Facilities Development public website:

49 Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify the division of work  
50 they are bidding on when requesting Bidding Documents online. No deposit is required to obtain documents for  
51 bidding purposes.

53 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD Information  
54 System.

56 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**  
57 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**

1 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**  
2 **affect the Federal Davis Bacon Act requirements.**

3  
4 A pre-bid tour is highly recommended prior to submitting a bid for this work.

5 A non-mandatory pre-bid walk thru will be held on September 12, 2023 promptly at 10:00 AM.

6 Meet in the main entrance of the Central Heating Plant.

7 All persons wanting to attend the pre-bid walk thru will need to contact Mark Wenzel at the Institution a minimum  
8 of 24 hours prior to the pre-bid conference.

9  
10 Failure to visit the site or failure to examine any and all Contract Documents will in no way relieve the successful  
11 contractor from the necessity of furnishing any materials or equipment, or performing any work, that may be  
12 required to complete the work in accordance with the Contract Documents.
