14 OWNER: State of Wisconsin, Department of Administration, Division of Facilities Development,
15 hereinafter termed DFD.

16
17 **All potential bidders must be certified by DOA prior to submitting bids on state construction**
18 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor
19 certification applications and instructions for completing the form may be obtained from the DOA Website

23 **Only bidders who have been certified by DOA as a qualified and responsible bidder in the**
24 **ELECTRICAL division of work may bid on this project.**

25
26 **This project is being let using a new single trade bidding and contracting process. When 85% or**
27 **more of the construction cost of a project could be completed by a Single Trade Contractor**
28 **(mechanical, electrical, plumbing, or fire protection), the Department may bid and contract all work**
29 **of that construction project directly to a Single Trade Contractor. The State will enter into a single**
30 **contract with the lowest, qualified, responsible, certified single trade MEP contractor. Single trade**
31 **MEP contractors may bid on single trade projects up to their current division of work certification**
32 **level for that trade. All Work for this project will be awarded to a single trade ELECTRICAL**
33 **contractor. Bidders shall submit a Single Base Bid for all Work.**

35 Sealed bids will be received as follows, before the time indicated above:

37 **original wet signatures or properly transmitted electronic signatures (only PDF files will be**

- 41 • **Hand delivery to the drop box labeled SEALED BIDS ONLY in front of the State of**
42 **Wisconsin Administration Building located at 101 East Wilson Street, Madison, Wisconsin**

45 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the
46 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.
47 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference
48 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results
49 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

1 In general the work consists of electrical work that includes providing new emergency generator
2 systems at four campus buildings, associated demolition and normal power equipment upgrades as
3 follows:

4 Lincoln Hall: New work includes installation of a new exterior pad mounted emergency generator and
5 connections as required to connect the new generator to the existing generator power distribution
6 system.

7
8 Swart Hall: New work includes installation of a new exterior pad mounted emergency generator, new
9 automatic transfer switches, new generator power distribution equipment, conduits and conductors as
10 required to provide generator power distribution that meets current code requirements.

11
12 Arts & Communications Center: New work includes installation of a new exterior pad mounted
13 emergency generator, new automatic transfer switches, new generator power distribution equipment,
14 conduit and conductors as required to provide generator power distribution that meets current code
15 requirements. Additional new work includes installation of two new service entrance switchboards.

16
17 Radford Hall: New work includes installation of new service entrance equipment. Additional new
18 work includes installation of a new exterior pad mounted emergency generator, new automatic transfer
19 switches, new generator power distribution equipment, conduits and conductors as required to provide
20 generator power distribution that meets current code requirements.

23 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in
24 PDF format); as a downloadable file from the Division's Projects Bidding website (see website address
25 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities
26 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding
27 information, including plan holders lists are available on the Division of Facilities Development public
28 website: <https://doa.wi.gov/Pages/AboutDOA/FacilitiesDevelopment.aspx>. After opening the web page,
29 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify
30 the division of work they are bidding on when requesting Bidding Documents online. No deposit is
31 required to obtain documents for bidding purposes.

33 **Base Bids will be received as follows: A single lump sum bid for All Work.**

35 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

37 Contract offer, and construction phase records will be processed electronically on the WisBuild™ DFD
38 Information System.

40 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing
41 wage laws. Effective September 23, 2017, state prevailing wage requirements on state building
42 projects no longer apply. These changes take effect for projects advertised for bid after September
43 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**
