12 hereinafter termed DFD.

13 **All potential bidders must be certified by DOA prior to submitting bids on state construction**  
14 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor  
15 certification applications and instructions for completing the form may be obtained from the DOA Website

21 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the  
22 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5  
23 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each  
24 applicable MEP division of work. These successful MEP bids must be included in all general prime  
25 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will  
26 publicly open general prime contractor bids. **General prime contractor bids that do not include the**  
27 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,  
28 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts  
29 with the successful MEP bidders. If a project does not include any mechanical, electrical, plumbing, or fire  
30 protection divisions of work, DFD will bid one bid package for all work to general prime contractors.

32 Sealed bids will be received as follows, before the time indicated above:

42 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the  
43 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.

44 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference  
45 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results  
46 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

49 In general, the work consists of: upgrading and modernization of a three stop hydraulic elevator including a  
50 new programmable microprocessor controller with a leveling system and soft start, battery lowering  
51 feature, new hoistway limit switches, new car top inspection station and pit stop switch, new machine room  
52 and hoistway wiring and travel cables, new hall call buttons, new closed loop door operators, new non-

1 contact door protection device, hoistway access switches (top and bottom), jamb braille plates at hoistway  
2 entrances, submersible power unit (motor, pump, control valve and muffler), new oil, new door equipment,  
3 new ceiling with LED lighting, new cab wall panels, hoistway lighting and GFCI outlets. New HVAC  
4 mini split unit to be installed in Elevator Equipment Room.

8 **Notice is hereby given in accordance with Section 16.855(10), Wisconsin Statutes, that the Division**  
9 **believes it is in the best interests of the State to contract the following work from only one source,**  
10 **without the usual statutory procedures:**

12 • **Section 28 31 00 - Fire Detection and Alarm; Existing fire alarm control panel is a Notifier**  
13 **NFS2 640. Provide devices as shown on drawings. Provide additional appurtenances as**  
14 **required for a fully functioning system.**

16 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in  
17 PDF format): as a downloadable file from the Division's Projects Bidding website (see website address  
18 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities  
19 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding  
20 information, including plan holders lists are available on the Division of Facilities Development public

22 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify  
23 the division of work they are bidding on when requesting Bidding Documents online. No deposit is  
24 required to obtain documents for bidding purposes.

26 **Base Bid will be received for: A single lump sum bid for All Work.**

27  
28 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

29  
30 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD  
31 Information System.

32  
33 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing**  
34 **wage laws. Effective September 23, 2017, state prevailing wage requirements on state building**  
35 **projects no longer apply. These changes take effect for projects advertised for bid after September**  
36 **23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

37  
38 A non-mandatory pre-bid tour is scheduled for **Tuesday, May 9, 2023** promptly at **10:00 AM**, UW River  
39 Falls, Wyman Education Building, Ground Floor Entrance (East). It is encouraged that contractors attend.
