13 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is advertising for bids from certified
14 contractors for the above project.

16 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**
17 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes
18 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

32 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time
33 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

34 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference number:

36 bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be opened after 2:00 P.M. CDT.

39 In general the work consists of: The replacement and upsizing of aged water lines, well cleaning, replacement of the
40 existing well pump, replacement of existing buried pressure tanks with new pressure tanks within the toilet shower
41 building (TSB), installation of a VFD and pressure transducer, and connection of the TSB well to the larger water
42 system for redundancy in the campground at Yellowstone Lake State Park.

44 Construction bidding documents (drawings, specifications and addenda) may be obtained only as downloadable
45 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding
46 documents may also be available at various Builders' Exchanges. Additional project bidding information, including

53 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD Information
54 System.

56 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**
57 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**

1 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**
2 **affect the Federal Davis Bacon Act requirements.**

4 There will be a non-mandatory open house on February 28, 2023 from 1:00pm – 3:00pm. Buildings will be open
5 during this time to be viewed at contractor’s convenience. Additional private viewings cannot be guaranteed. Please
