14 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is
15 advertising for bids from certified contractors for the above project.
16

17 **NOTICE: All potential bidders must become certified by DOA prior to submitting bids on**
18 **state construction projects with budgets over \$50,000.** All bids received from contractors
19 who are not certified will be rejected. **These changes take effect January 1, 2014.** Contractor
20 certification applications and instructions for completing the form may be obtained from the DOA

25 Bids must be received at State of Wisconsin Administration Building, 101 East Wilson Street, 7th
26 Floor Reception Desk, Madison, Wisconsin 53703, on or before the closing date and time
27 indicated above.

29 In general the work consists of: **Disconnection and removal of three existing steam kettles,**
30 **removal of existing tile wall finishes and floor finishes, installation & mechanical**
31 **connections of new steam kettles & accessories. Minor floor concrete demolition to**
32 **increase size of floor drain pan.**

35 Construction bidding documents (drawings, specifications and addenda) may be obtained only
36 as downloadable electronic files (in PDF format) from the Division of Facilities Development
37 website. Construction bidding documents may also be available at various Builders' Exchanges.
38 Additional project construction bidding information, including plan holders list, is available on the
39 DFD website. Please note that a WisBuild login and password are required to download bidding
40 documents. Interested parties may request a WisBuild login and password at the DFD website –
41 allow 2 days to process login and password requests.

43 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's**
44 **prevailing wage laws. Effective September 23, 2017, state prevailing wage requirements**
45 **on state building projects no longer apply. These changes take effect for projects**
46 **advertised for bid after September 23, 2017. This change does not affect the Federal**
47 **Davis Bacon Act requirements.**

49 A non-mandatory pre-bid meeting will be held on July 12, 2022 at 10:00 am at the project site.

1 Attendees are instructed to follow mandatory procedures and background requirements indicated
2 in this document under "Agency Specific Requirements: Taycheedah Correctional Institution"
3 prior to attending meeting.

4
5 A minimum of 24 hours are required for security clearances.

6
7 Attendees will be asked to show a photo ID, pass through metal detector and sign in and out in
8 the visitor log book.

9
10 Attendees without the necessary approvals will be denied access into the facility.

11
12 Arrive at Main Gate Facility up to 30 minutes prior to scheduled meeting time for adequate security
13 instructions and clearance. Late arrivals may be denied access to project site.

14
15 Authorized attendees will be group-escorted to project site at stated meeting time and group-
16 escorted back to the Gate Facility at the end of pre-bid meeting.
