10 The Division of Facilities Development, hereinafter termed DFD, hereby announces that it is advertising for bids from certified  
11 contractors for the above project.

12 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**  
13 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes  
14 take effect January 1, 2014. Contractor certification applications and instructions for completing the form may be

28 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time  
29 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

30 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference number:

32 bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be opened after 2:00 P.M. CDT.

36 In general, the work consists of: Repairing three pieces of chilled water equipment around the Southern Wisconsin  
37 Center campus. First, replace the fill in the cooling tower serving Building #7. Second, overhaul chiller #2 in the  
38 CRSP building. Third, repair the structural steel supports under the cooling tower at the CRSP building.

51 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding

1 Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify the division of work  
2 they are bidding on when requesting Bidding Documents online. No deposit is required to obtain documents for  
3 bidding purposes.

5 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD Information  
6 System.

7  
8 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin’s prevailing wage laws.**  
9 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**  
10 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**  
11 **affect the Federal Davis Bacon Act requirements.**

12  
13 A non-mandatory pre-bid tour is scheduled for Tuesday, February 6, 2024, at 10:30 AM. Meet at the CRSP  
14 Building Chiller Room (parking lot by the adjacent cooling tower). It is encouraged that contractors attend. A/E
