Within 5 25 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each 26 applicable MEP division of work. These successful MEP bids must be included in all general prime 27 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will 28 publicly open general prime contractor bids. General prime contractor bids that do not include the successful MEP bids will be rejected. The state will enter into a single contract with the lowest, qualified, 29 30 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts 31 with the successful MEP bidders.
