12 **2:00 P.M., June 8, 2023.**

14 OWNER: State of Wisconsin, Department of Administration, Division of Facilities Development,  
15 hereinafter termed DFD.

16  
17 **All potential bidders must be certified by DOA prior to submitting bids on state construction**  
18 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor  
19 certification applications and instructions for completing the form may be obtained from the DOA Website

23 **Only bidders who have been certified by DOA as a qualified and responsible bidder in the**  
24 **ELECTRICAL division of work may bid on this project.**

25  
26 **This project is being let using a new single trade bidding and contracting process. When 85% or**  
27 **more of the construction cost of a project could be completed by a Single Trade Contractor**  
28 **(mechanical, electrical, plumbing, or fire protection), the Department may bid and contract all work**  
29 **of that construction project directly to a Single Trade Contractor. The State will enter into a single**  
30 **contract with the lowest, qualified, responsible, certified single trade MEP contractor. Single trade**  
31 **MEP contractors may bid on single trade projects up to their current division of work certification**  
32 **level for that trade. All Work for this project will be awarded to a single trade ELECTRICAL**  
33 **contractor. Bidders shall submit a Single Base Bid for all Work.**

35 Sealed bids will be received as follows, before the time indicated above:

37 **original wet signatures or properly transmitted electronic signatures (only PDF files will be**

- 39 • **US Mail or Third-party delivery (UPS, Fedex, or DHL) to State of Wisconsin,**

- 41 • **Hand delivery to the drop box labeled SEALED BIDS ONLY in front of the State of**  
42 **Wisconsin Administration Building located at 101 East Wilson Street, Madison, Wisconsin**  
43 **53703.**

45 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the  
46 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.  
47 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference  
48 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results  
49 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

53 In general the work consists of replacing existing door control programmable logic controllers, relays and  
54 networking equipment in multiple buildings.

2 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in  
3 PDF format): as a downloadable file from the Division’s Projects Bidding website (see website address  
4 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities  
5 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding  
6 information, including plan holders lists are available on the Division of Facilities Development public  
7 website: <https://doa.wi.gov/Pages/AboutDOA/FacilitiesDevelopment.aspx>. After opening the web page,  
8 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify  
9 the division of work they are bidding on when requesting Bidding Documents online. No deposit is  
10 required to obtain documents for bidding purposes.

11  
12 **Base Bids will be received as follows: A single lump sum bid for All Work.**

13  
14 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

15  
16 Contract offer, and construction phase records will be processed electronically on the WisBuild™ DFD  
17 Information System.

18  
19 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin’s prevailing  
20 wage laws. Effective September 23, 2017, state prevailing wage requirements on state building  
21 projects no longer apply. These changes take effect for projects advertised for bid after September  
22 23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**

23  
24  
25 A single non-mandatory pre-bid tour date has been set up for May 18, 2023 - 9:00AM at Sand Ridge  
26 Secure Treatment Center. It is encouraged that contractors attend. Contractors interested in attending the  
27 pre-bid tour shall send their full name, date of birth, and state driver's license number, via email to Jon  
28 Woggon, SRSTC Buildings and Grounds Superintendent, 608-847-1757, [jon.woggon@dhs.wisconsin.gov](mailto:jon.woggon@dhs.wisconsin.gov)  
29 by May 12, 2023, 2:00PM. Indicate the project number and bid tour time when sending the email. Limit  
30 of one (1) individual from any separate company for the pre-bid tour. Contractors attending the pre-bid  
31 tour shall meet at the Administration building main entry. All persons entering the facility shall comply  
32 with Covid protocol including wearing of surgical type masks. All persons visiting the site must first pass  
33 through COVID-19 health screening station located in G-Building. Masks must be worn at all times while  
34 on site, and 6-foot social distancing must be practiced.

36 Bidding Documents will be available online immediately upon the project being advertised for bid.
