13 OWNER: State of Wisconsin, Department of Administration, Division of Facilities Development,  
14 hereinafter termed DFD.

15  
16 **All potential bidders must be certified by DOA prior to submitting bids on state construction**  
17 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor  
18 certification applications and instructions for completing the form may be obtained from the DOA Website

22 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the  
23 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5  
24 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each  
25 applicable MEP division of work. These successful MEP bids must be included in all general prime  
26 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will  
27 publicly open general prime contractor bids. **General prime contractor bids that do not include the**  
28 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,  
29 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts  
30 with the successful MEP bidders. If a project does not include any mechanical, electrical, plumbing, or fire  
31 protection divisions of work, DFD will bid one bid package for all work to general prime contractors.

33 Sealed bids will be received as follows, before the time indicated above:

35 **original wet signatures or properly transmitted electronic signatures (only PDF files will be**

- 39 • **Hand delivery to the drop box labeled SEALED BIDS ONLY in front of the State of**  
40 **Wisconsin Administration Building located at 101 East Wilson Street, Madison, Wisconsin**

43 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the  
44 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.

45 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference  
46 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results  
47 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

50 In general, the work consists of: renovating the heating and ventilation system in select areas; installing five  
51 (5) new air conditioning units in select areas; providing new mechanical system controls for select spaces;  
52 resolving heating, ventilating, and air conditioning deficiencies in select spaces; replacing the gymnasium  
53 ceiling; replacing electrical primary and secondary transformer, switchgear, distribution panels, and  
54 emergency generator.

10 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in  
11 PDF format); as a downloadable file from the Division's Projects Bidding website (see website address  
12 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities  
13 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding  
14 information, including plan holders lists are available on the Division of Facilities Development public

16 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify  
17 the division of work they are bidding on when requesting Bidding Documents online. No deposit is  
18 required to obtain documents for bidding purposes.

20 **Base Bid will be received for: A single lump sum bid for All Work.**  
21

22 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.

24 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD  
25 Information System.  
26

27 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing**  
28 **wage laws. Effective September 23, 2017, state prevailing wage requirements on state building**  
29 **projects no longer apply. These changes take effect for projects advertised for bid after September**  
30 **23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**  
31

32 A non-mandatory pre-bid tour is scheduled for April 3, 2024 at 9:00am at the Williams Fieldhouse Lobby  
33 near Parking Lot 26. Parking is available in Lot 26, accessed from Championship Drive
