13 OWNER: State of Wisconsin, Department of Administration, Division of Facilities Development,
14 hereinafter termed DFD.

15
16 **All potential bidders must be certified by DOA prior to submitting bids on state construction**
17 **projects over \$50,000.** All bids received from contractors who are not certified will be rejected. Contractor
18 certification applications and instructions for completing the form may be obtained from the DOA Website

22 This project is being let using the single prime bidding and contracting process. DFD will publicly bid the
23 applicable mechanical, electrical, plumbing, and fire protection (MEP) divisions of work **first**. Within 5
24 days of the MEP bid opening, DFD will identify a lowest, qualified, responsible, certified bidder in each
25 applicable MEP division of work. These successful MEP bids must be included in all general prime
26 contractor bids received. No later than 5 days after DFD identifies the successful MEP bids, DFD will
27 publicly open general prime contractor bids. **General prime contractor bids that do not include the**
28 **successful MEP bids will be rejected.** The state will enter into a single contract with the lowest, qualified,
29 responsible, certified general prime contractor and this general prime contractor will enter into subcontracts
30 with the successful MEP bidders. **If a project does not include any mechanical, electrical, plumbing, or**
31 **fire protection divisions of work, DFD will bid one bid package for all work to general prime**
32 **contractors.**

34 Sealed bids will be received as follows, before the time indicated above:

44 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the
45 time specified for the bid submission. Third party delivery is entirely at the bidder's risk.

46 Bid opening will be conducted via Microsoft Teams. Bidders may call the Microsoft Teams teleconference
47 number: (608) 571-2209, conference ID: 484 588 360#, on the day of the bid to hear the bid results
48 announced on the day bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be

51 In general, the work consists of: the cleaning, restoration, and preservation of decoratively painted plaster
52 ceiling areas (64 panels of various sizes) in the three rings of the ground floor Rotunda of the Wisconsin
53 State Capitol Building. Work is required to be conducted with a continuous work effort/presence. Multiple
54 panels may be treated simultaneously.

1 All painted ceiling surfaces will receive conservation cleaning to remove surface dirt/dust/grime. The work
2 includes the manual removal of the darkened varnish coating over the entire panel on all panels and
3 conservation of the intact finishes on all the panels. The scope includes varnish removal, application of an
4 isolation layer, plaster stabilization, paint consolidation, infills where necessary, inpainting and in-gilding
5 of losses, patinating and toning of new finish areas to match adjacent existing finishes, and final varnish.
6
7 Areas of plaster loss are required be repaired using appropriate plaster material. Areas of repaired plaster
8 will be in-painted to match the original color palette and any areas of decorative loss will be in-painted
9 and/or in-gilded to match the original color palette.

11 On panels that have been repainted and are not original, the work includes repainting to match the
12 conserved panels. Where there is a significant quantity of painting loss, the scope will include repainting in
13 lieu of touch-ups to provide a cohesive appearance. New gilding will be toned in to match the surrounding
14 panels. At the completion of the conservation, a non-yellowing, reversible art conservation isolation
15 varnish will be applied to stabilize, saturate, and unify the decorative ceiling panels.

17 Access to the work area will be accomplished via scaffold to be provided by the successful bidder. This
18 work includes the protection of the floors, walls, and work area during the project.
19
20 Bidding documents (drawings, specifications, and addenda) may be obtained only as electronic files (in
21 PDF format): as a downloadable file from the Division’s Projects Bidding website (see website address
22 below) and/or on compact discs or DVD by ordering from the Construction Project Bidding Opportunities
23 webpage. Bidding documents may also be seen at various Builders' Exchanges. Additional project bidding
24 information, including plan holders lists are available on the Division of Facilities Development public
25 website: <https://doa.wi.gov/Pages/AboutDOA/FacilitiesDevelopment.aspx>. After opening the web page,
26 select Current Construction Project Bidding Opportunities at the bottom of the screen. Bidder shall identify
27 the division of work they are bidding on when requesting Bidding Documents online. No deposit is
28 required to obtain documents for bidding purposes.

30 **Base Bid will be received for: A single lump sum bid for All Work.**
31
32 Bid Guarantee in the amount of 10% of the Bid must accompany each bid submitted.
33
34 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD
35 Information System.

37 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin’s prevailing**
38 **wage laws. Effective September 23, 2017, state prevailing wage requirements on state building**
39 **projects no longer apply. These changes take effect for projects advertised for bid after September**
40 **23, 2017. This change does not affect the Federal Davis Bacon Act requirements.**
41
