11 contractors for the above project.

12 **All potential bidders must become certified by DOA prior to submitting bids on state construction projects**
13 **with budgets over \$50,000.** All bids received from contractors who are not certified will be rejected. These changes

27 The bidder is responsible for the sealed bid being delivered to the indicated location or email before the time
28 specified for the bid submission. Third party delivery is entirely at the bidder's risk.

31 bids are due. The conference line will be open at 1:45 P.M. CDT and all bids will be opened after 2:00 P.M. CDT.

35 In general, the work consists of: The repair and reglazing of existing steel windows and the preparation, priming and
36 painting the metal roof, metal exterior wall, windows, and doors.

39 electronic files (in PDF format) from the Division of Facilities Development website. Construction bidding
40 documents may also be available at various Builders' Exchanges. Additional project bidding information, including

47 Contract offer and construction phase records will be processed electronically on the WisBuild™ DFD Information
48 System.

50 **The 2017-2019 Wisconsin State Budget (2017 Wisconsin Act 59) repealed Wisconsin's prevailing wage laws.**
51 **Effective September 23, 2017, state prevailing wage requirements on state building projects no longer apply.**
52 **These changes take effect for projects advertised for bid after September 23, 2017. This change does not**
53 **affect the Federal Davis Bacon Act requirements.**
